REUNION! IT'S NOT TOO LATE

You can still register for this summer's Alumni Reunion to be held July 2 – 4 in Overland Park, Kansas. You don't want to miss it as it promises to be an extraordinary event. A registration form can be found elsewhere in this issue.

The newly remodeled Overland Park Marriott will be the site. There is a special room rate for attendees. Hurry, to obtain the special rate you must register by June 12.

If you are flying to the reunion, Quicksilver Airport Shuttle charges \$35.00 to take an individual to the Marriott. Additional passengers on the same trip can ride for only \$7.50 each. Reservations must be made for your shuttle trip a minimum of 48 hours in advance. Note that a 10% discount is available to those who reserve their trip at least 14 days in advance. A significant feature of this reunion will be the induction of the initial group of members of the C of E Athletic Hall of Fame. This will take place at the Saturday breakfast.

Plans have now come together for various mini-reunions within the larger gathering. Both the Class of 1959 and the Class of 1960 are planning their own buffet luncheons on Saturday. Members of the Athena Society will be introduced at the Saturday evening banquet. Other scheduled events that are set for hospitality rooms include reunions of the Class of 1965, Phi Mu Alpha Sinfonia and Mu Phi Epsilon. Any attendees interested in singing in the choir at the Sunday Worship Service will be asked to attend a Saturday afternoon practice.

Note also that every C of E alumnus will be asked to have his or her photo taken for the directory that will be published after the reunion. There will be some fascinating items from every college era in the Memorabilia Room including a Gwinn Henry display. Also there will be some surprising give-aways from C of E's past for fortunate alumni. Items to be auctioned at the Saturday evening live auction will also be on display nearby.

Scholarship Fund Drive

The Board of your Alumni Association has decided to embark on a major fund drive to build our scholarship fund. The Board has appointed a sub-committee of three of its members to lead this effort.

Awarding college scholarships to deserving descendants of alumni, former C of E students and staff is one of the most significant activities of our association. Scholarships are awarded annually. Every year there are significantly more deserving applicants than there are scholarships available. The number of scholarships and the amount of money awarded with each vary depending upon the financial state of the scholarship fund. In recent years four to six scholarships have been awarded

with each scholarship worth \$2,000 to \$2,500.

Our scholarship fund is invested through an arm of the Presbyterian Church that manages investments. As was the case with all similar funds, the recent economic downturn took a toll on our reserves. However, we are now beginning a slow rebound.

Your Board is now looking ahead to the time when the Alumni Association ages to the point where dissolution is necessary. The scholarship program is seen as our continuing legacy. To this end the fund drive will attempt to create an endowment that will allow us to continue to help deserving descendants in the C of E family.

Your Board believes that applications will continue to come for many years. In fact, with increasingly sophisticated scholarship directories and search engines, the possibility exists for more applicants than heretofore.

SO MUCH TO CELEBRATE

Our reunions have been wonderful. One of the highlights has been the reminiscences and celebration of the athletic achievements that have been so outstanding and even astounding at this small college. My grandchildren are amazed when I tell them of past accomplishments – such as football victories over KU and MU and how the namesake of the Gwinn Henry Cemetery went from coaching football at C. of E. to an outstanding coaching career at MU. I regale them with how players from our tiny college were named to the NAIA All-American teams, how some went on to play in the NFL and how our coach was named NAIA coach of the year. And most of the stories I tell are true!

I was privileged to attend during the glory years of football players like Lem Harkey, Bill Danenhauer and Willie Gaines, and I enjoyed the basketball exploits of Charlie Dehlinger, among others. Other grads glory in other great eras in the annals of C of E athletics. These were outstanding aspects of our college life. Though I regret not following baseball and some of the other sports, nearly everyone on campus could be found in the stands for football games.

The athletes also had the advantage of the E Club that has been a focal point of organizing and celebrating our athletic memories at recent reunions. I am grateful for these tributes to the extraordinary sports memories that flavored all our college days. In retrospect, however, there are other college highlights that we have failed to recognize and recall with the same level of enthusiasm. For many of us, some of our fondest memories came from the ambitious music program the college offered in many different decades. For some there was the grand era presided over by Dr. Dan Hirschler (concurrently President of the College and Dean of the School of Music). The high standards and deserved reputation of musical excellence attracted first-rate orchestras, including the Walter Damrosch led New York Symphony, to the chapel stage. I know little about these exploits but would enjoy recollections of those outstanding accomplishments.

During my years, headed by John Lewis and Dr. Jacobson, the music program was unexpectedly ambitious for such a small school. In later years the storied Toppers were a definite highlight. Music did not involve as many of us as athletics, of course, but how many institutions of higher learning included 25% of the campus population in their college choir? During my years, the Chorale tackled major works such as Brahms' and Mozart's *Requiems*, Bach's *Magnificat*, *St. Matthew Passion*, Handel's *Messiah* and Vivaldi's *Gloria* among others.

No doubt a highlight of those years was the presentation of Gian Carlo Menotti's 1951 made for TV opera, *Amahl and the Night Visitors*. In 1952 C. of E. presented one of the very first non-TV performances of this classic. It featured Maxine (White) Mitchell as Amahl and Russelle (Seeberger) Leggett as his mother. The reviewer for the *Emporia Gazette* called it a "miracle" and pled with the college to repeat the performance so

that he could fill the Kenyon Hall auditorium with townsfolk. We have not celebrated the many musical accomplishments of the college to the extent that many of us feel that they might have been recalled. Outstanding graduates of the college have enriched the music life of thousands of students where they have taught as surely as graduates have advanced the cause of athletics through coaching at high schools and colleges across the land. I think only of my late sister-in-law Ruth Keraus, whose career as a music instructor and as music director of the Southeast Iowa Symphony Orchestra has been an inspiration to countless musicians. There must be others as well if we could only know and celebrate their achievements.

There were other aspects of the arts and drama at the college whose secret exploits have been hidden from view. I regret these stories have not been told.

A third feature of the college has always been a surprisingly strong academic offering for a school of its size. I was impressed with the athletics and the music, which were both drawing cards that attracted me to attend. I certainly did not choose the college for its academic rigor. As a matter of fact, one of the most attractive features of the school, for my money, was the possibility of graduating in certain programs without any foreign language requirements. I never planned to take New Testament Greek as an elective course my senior year. Nor was I prepared for either the demanding challenge presented by Dr. Flournoy to many generations of students or the mind stretching requirements of many of the other dedicated faculty.

The College has always been proud of the achievements of accomplished graduates and is able to publish some of these in this newsletter. I understand that there is an effort to gather members of the Athena Society at the upcoming reunion, but that group would be such a small representation of the academic prowess of the College. I wish that there were some way to highlight the late bloomers and mediocre high school students who flourished in the rich nurture of this small college into thinkers, writers, educators and contributors to society in a variety of noteworthy ways.

My plea is for some of the creative minds among our esteemed alums to find a way to celebrate and highlight some of the other wonderful features of our college years to lift up along with the marvelous athletic achievements we have so fully celebrated at our reunions.

Mu Phi Epsilon, C of E's music sorority, will hold a mini-reunion within July's Alumni Reunion. It is being organized by **Ernestine (Largent) Brown, A63**. Former Mu Phi members planning on attending are urged to contact Ernie by e-mail at forbrowne@teacher.com.

The sorority was founded November 13, 1903, at the Cincinnati College of Music. The chapter at C of E was founded March 15, 1929.

Today Mu Phi Epsilon continues to exist with over 100 active campus chapters and an alumni association that even has its own foundation. It is no longer a sorority. In the 1970's Title

IX mandated that all such societies be opened to coeducational membership. Mu Phi Epsilon became coeducational in 1977. During the sorority's forty-five years on the C of E campus, membership consisted of students, faculty and even some faculty wives. The organization promoted the advancement of music as well as "scholarship, musicianship and friendship, along with encouraging each member's loyalty to their Alma Mater."

All living former members are urged to plan to attend this summer's Alumni Reunion and to reconnect with other Mu Phi Epsilon members as well as with classmates.
